## A RESOLUTION TO APPOINT A RULES COMMITTEE OF THE WEAKLEY COUNTY BOARD OF COMMISSIONERS

WHEREAS, the County Board of Commissioners has such a committee in place, and the need may arise to amend said rules and with the need to appoint committees of the Weakley County Board of Commissioners; and

**WHEREAS**, the members of the County Commission will be elected in the August 2, 2018, general election; and

WHEREAS, new officials, as well as incumbent officials and the general public need to be knowledgeable of the rules, procedures, and committees of the county legislative body.

**NOW, THEREFORE, BE IS RESOLVED** by the Weakley County Legislative Body, meeting in regular session on this 26<sup>th</sup> day of July, 2018, that:

**SECTION 1.** Nine (9) County Commissioners be appointed to serve on a committee to study and recommend the rules, procedures, and committee structure of the county legislative body to make recommendations for committee assignments and to make nominations to fill offices as required by law to be filled by the County Legislative Body.

## **SECTION 2.** The committee members appointed shall be as follows:

In the event that any of the above named commissioners is not reelected, the elected commissioner with the highest vote total in each respective district will be appointed as a member of the Rules Committee.

**SECTION 3.** The committee shall report their recommendations to the county legislative body at the first meeting, whether regular or called, held on or after September 1, 2018. The committee report shall be the first item of business considered at such meeting and in case of a called meeting, the committee report shall be included in the call.

**SECTION 4:** For organizational purposes and until new rules are adopted, the Weakley County Board of Commissioners will operate under the rules approved September 17, 2014 as amended.

**SECTION 5:** All resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

**SECTION 6:** This resolution takes effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
