The Weakley County Public Safety Committee met on Tuesday, January 7, 2020, at 9:00 a.m. in the conference room at the Board of Education in Dresden. Others present included County Mayor Jake Bynum, Finance Director John Liggett, Sheriff Mike Wilson, Dispatch Director Christy Fulcher, Emergency Management Director Ray Wiggington, Clerk and Master Regina VanCleave, and one representative of the media.

I-II. CALL TO ORDER – APPROVAL OF MINUTES

Chairperson Vincent called the meeting to order at 9:00 a.m. and called for the consideration of the minutes from the meeting that was held on November 8, 2019. Commissioner Hawks made the motion to approve, and with a second by Commissioner Bell, the motion passed unanimously.

IV. NEW BUSINESS

A. RESOLUTIONS

1. Resolution No. 2020-30: This resolution moves \$2,625 out of funds restricted for the sexual offender registry and moves those monies into 54110-307 (Sheriff's Department – Communication) in the General Fund budget. Sheriff Wilson was recognized and explained that his department is required to monitor a certain number of individuals who are on the sex offender registry. Commissioner Pope made the motion to approve the resolution and recommend it to the Finance, Ways, and Means Committee, and with a second by Commissioner Hawks, the motion passed unanimously.

2. Resolution No. 2020-33: This resolution adopts a mitigation plan for Weakley County, Tennessee, and the incorporated cities of Sharon, Dresden, Greenfield, Gleason, and Martin. EMA Director Wiggington was recognized and explained that this five-year plan is mandated by TEMA and is approved pending adoption. He mentioned that changes to the plan were to list of projects that the county had planned, and that all municipalities must also adopt a plan through their respective cities. Commissioner Pope made the motion to approve the resolution and recommend it to the full county commission, and with a second by Commissioner Bell, the motion passed unanimously.


V. OTHER BUSINESS

VI. ADJOURN


Having no other business, Commissioner Hawks made the motion to adjourn, and with a second by Commissioner Pope, the meeting was adjourned at 9:22 a.m.
