

A Resolution to Adjust the 1974-75

WHEREAS, it has been determined that certain adjustments to anticipated fund availability and appropriations are needed in certain areas of the 1974-75 Budget controlling operations of the County General Fund, and,

WHEREAS, additional appropriations are needed in given areas and other appropriations are in excess of needs, and,

WHEREAS, IT APPEARS THAT revenues in excess of original anticipations together with unneeded appropriations in given instances will be adequate to finance these adjustments and appropriations.

NOW, THEREFORE BE IT RESOLVED, by the Quarterly County Court of Weakley County, Tennessee, that the Weakley County General Fund Budget for fiscal 1974-75 is amended as outlined:
