

RESOLUTION NO. 2000-52

RESOLUTION AUTHORIZING BUDGET AMENDMENT  
TO THE WEAKLEY COUNTY, TENNESSEE GENERAL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2000.

WHEREAS, the General Sessions Court has assumed the responsibility of receipting the fee for the Financial Planning Class; and

WHEREAS, Weakley County receives seventy-five dollars (\$75) per individual that attends the Financial Planning Class and the instructor's fee is one-half of the tuition; and

WHEREAS, the General Session Court has collected \$9,200 additional funds and will expense \$4,150 of those funds; and

WHEREAS, a budget amendment is necessary in the General Sessions 1999-2000 budget.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 12<sup>th</sup> day of June 2000 in Dresden, Tennessee this resolution is hereby approved.

SECTION 1. The Weakley County General Fund is hereby amended as follows:






