

RESOLUTION NO. 1974-12

A RESOLUTION TO APPROPRIATE FROM THE FUNDS OF THE WEAKLEY COUNTY GENERAL FUND SUCH AMOUNT OR AMOUNTS AS MAY BE REQUIRED TO PAY FOR THE SERVICES OF AN ACTUARY IN DETERMINING THE COST TO SAID WEAKLEY COUNTY WITH RESPECT TO THE EMPLOYEES OF SAID WEAKLEY COUNTY PARTICIPATING IN THE TENNESSEE CONSOLIDATED RETIREMENT SYSTEM.

WHEREAS, the Weakley County Quarterly Court is contemplating petitioning the Board of Trustees of the Tennessee Consolidated Retirement System to approve coverage for its employees in the Tennessee Consolidated Retirement System as so authorized under Public Chapter #814, Section 10, and

WHEREAS, said Weakley County Quarterly Court desires to consider the cost of such coverage prior to final approval of said coverage, and

WHEREAS, the determination of such cost requires the services of an Actuary who, under State Law, should be compensated for such services from said County General funds.

NOW, THEREFORE, BE IT RESOLVED BY THE Weakley County Quarterly Court

1. There is hereby appropriated from the funds of the Weakley County General Fund such amounts required to compensate for the actuarial services determining the cost or costs to the said county of the participation of its employees in the Tennessee Consolidated Retirement System.

2. Upon receipt of such determination the County Judge is hereby authorized and directed to pay over the amount or amounts appropriated in the First Section hereinabove contained, to the Tennessee Consolidated Retirement System, or as directed by the Director of the Tennessee Consolidated Retirement System. This appropriation is not to exceed \$300.00. The Weakley County General Fund is amended for this amount.

RESOLUTION NO. 1974-13
