

## RESOLUTION NO. 1976-40:

## RESOLUTION OF THE QUARTERLY COUNTY COURT OF WEAKLEY COUNTY, TENNESSEE TO AMEND THE 1975-76 COUNTY GENERAL AND HIGHWAY FUND BUDGETS.

WHEREAS, the General Assembly of the State of Tennessee has determined that salaries of certain county officials be increased on September 1 of each year based on the per cent of change in the average consumer price index for the preceding year; and,

WHEREAS, the United State Bureau of Labor Statistics has determined the per cent of change in the average consumer price index to be eleven (11) per cent for 1974; and,

WHEREAS, all county officials except the General Sessions Judge, Sheriff, Assessor of Property and Highway Supervisor are currently drawing their salaries reflecting this increase; and,

WHEREAS, The General Sessions Judge, Sheriff, Assessor of Property and Highway Supervisor of Weakley County are currently drawing salaries reflecting an increase of two and one-half (2½) per cent or eight and one-half (8½) per cent less than that required by law; and,

WHEREAS, it is the intent of this Quarterly Court to abide by all statutes governing the operation of county government; and,

WHEREAS, the County Trustee has transferred into the County General Fund \$10,000 more funds than originally anticipated.

NOW, THEREFORE, BE IT RESOLVED by the Quarterly County Court of Weakley County, Tennessee, as follows:

SECTION 1. That the County General Fund budget be amended as follows:

SECTION 2. That the Highway Fund Budget be amended as follows.

## INCREASE:

No. 1210.1 Salary - Supervisor \$ 977.50

## DECREASE:

No. 1240.2 Labor - Common \$ 977.50

BE IT FURTHER RESOLVED, that all orders or resolutions in conflict herewith be and the same hereby repealed insofar as such conflict exists and this resolution shall become effective upon its passage.
