RESOLUTION NO. 1979-27:

Resolution of the Board of County Commissioners of Weakley County, Tennessee, Approving Chapter 60, Private Acts of 1979.

WHEREAS, the General Assembly of the State of Tennessee has enacted Chapter 60, Private Acts of 1979, which amends Chapter 64 of the Private Acts of 1949, as amended, which governs the operation of the Weakley County Highway Departments; and

WHEREAS, the Weakley County Board of County Commissioners, at the January 1979 Term, requested this Act be passed; and

WHEREAS, the Constitution of the State of Tennessee and Section 4 of the Act requires that this Act shall have no effect unless approved by a two-thirds (2/3) vote of the Board of County Commissioners of Weakley County.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Weakley County that Chapter 60, Private Acts of 1979 is approved.

BE IT FURTHER RESOLVED, that the presiding officer of the Board certify the approval or non-approval of this Act to the Secretary of State as required by the Act..
