

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF WEAKLEY COUNTY, TENNESSEE, TO ACCEPT A PROPOSAL DATED SEPTEMBER 11, 1985, SUBMITTED TO SAID WEAKLEY COUNTY, TENNESSEE BY THE STATE OF TENNESSEE, DEPARTMENT OF TRANSPORTATION, INVOLVING A PROJECT DESIGNATED BY SAID DEPARTMENT AS PROJECT NO. 92137-5202-04, F-22(4) 92137-2208-14, SR-22 from 0.247 MILE WEST OF US. 45 EAST TO 0.041 MILE EAST OF LEE ROAD OBION COUNTY - 3.769 MILES PROPOSALS TO COUNTY OF WEAKLEY.

WHEREAS, said project will benefit both Weakley County and the State of Tennessee, Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Weakley County as follows:

SECTION 1. That Weakley County does hereby accept the terms of the proposal made to said County by the State of Tennessee, Department of Transportation, dated September 11, 1985. A copy of said proposal to Weakley County No. 92137-5202-04; F-22(4), 92137-2208-14, State Route 22 from 0.247 Miles West of U.S. 45 East to 0.041 Miles East of Lee Road (3.769 Miles), has been filed with the County Clerk and is hereby made a part of this Resolution by reference.

SECTION 2. That the County Executive is hereby authorized to execute, if necessary, any agreement on behalf of Weakley County for implementation and administration of the terms set forth in said proposal.

SECTION 3. BE IT FURTHER RESOLVED, that this resolution shall take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
