**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2014.**

**WHEREAS**, the Weakley County Courthouse's current internet connection is a very slow DSL connection which continues to causes problems hindering the collections of revenues; and

**WHEREAS**, the Weakley County Courthouse internet will be upgraded and replaced by a fiber connection, the project will include installing the necessary equipment to connect all offices, firewall protection and wireless access points to be used by courthouse staff, court attorneys, auditors and others; and

**WHEREAS**, the Courthouse Committee recommends this wiring project and data processing reserves are available to fund this project.

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 17<sup>th</sup> day of March 2014 in Dresden, Tennessee that:

**SECTION 1.** The Weakley County General Fund is hereby amended as follows:




