

## RESOLUTION NO. 2015-02

**RESOLUTION FIXING THE TAX LEVY FOR WEAKLEY COUNTY, TENNESSEE  
FOR THE FISCAL YEAR BEGINNING JULY 1, 2014.**

**SECTION 1. BE IT RESOLVED** by the Board of County Commissioners of Weakley County, Tennessee, in a regular session on this the 28th day of July, 2014, that the combined property tax rate for Weakley County, Tennessee for the Fiscal Year beginning July 1, 2014, shall be \$2.1302 on each \$100.00 of taxable property, which is to provide revenue for each of the following levies:

COUNTY GENERAL	\$ 0.6400
SOLID WASTE	0.0052
HIGHWAY	0.2150
GENERAL PURPOSE SCHOOL	0.7200
DEBT SERVICE	0.5500

**SECTION 2. BE IT FURTHER RESOLVED**, that there is hereby levied a gross receipts tax as provided by law. The proceeds of the gross receipts tax herein levied shall accrue to the County General Fund.

**SECTION 3. BE IT FURTHER RESOLVED**, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby rescinded.


