The Rules Committee met on Monday, September 15, 2014 at the Weakley County Courthouse in the county commission courtroom. Others present included Jake Bynum-County Mayor, Randy Frazier-Director of Schools, Gordon Morris-School Board member, Keith Jones-Juvenile Service Officer, and other commissioners.

Chairman Westbrook called the Rules Committee meeting to order.

**OLD BUSINESS:**

Commissioner Bynum made the motion to approve the September 1, 2014 Rules Committee minutes and with a second by Commissioner Jones the motion passed unanimously.

**NEW BUSINESS:**

**Weakley County Economic Development Board Vacancy**

Chairman Westbrook stated Wendell Alexander submitted his resignation from the Weakley County Economic Development Board in June 2014. The HEED committee recommends the appointment of Alex Bynum to fill the unexpired term. Commissioner Owen made the motion to recommend Alex Bynum to fill the unexpired term on the Weakley County Economic Development Board and with a second by Commissioner Vincent the motion passed unanimously.

Chairman Westbrook asked if any committee members wish to amend Resolution #21015-04 the rules of the commission. No one offered any amendments.

**Resolution #2015-09**

Commissioner Hawks introduced Resolution #2015-09 that would change the formation of the rules committee. The resolution states the nine (9) county commissioners appointed, one from each county commission district, shall be the persons receiving the most votes in their respective districts in the most recent Weakley County general election. Commissioner Hawks made the motion to approve Resolution #2015-09; however the motion died for lack of a second.

**Committee Appointments**

Commissioner Owen made the motion to reconsider the committee appointments. Commissioner Jones seconded the motion and it passed. Commissioner Owen stated that FWM has six (6) members with three (3) being from Martin. Commissioner Owen made the motion to swap Commissioner Larry Taylor to HEED committee with Commissioner Greg Usery to the FWM committee. Voice vote was taken, the motion passed with Commissioner Hawks opposing.


Commissioner Owen made the motion to adjourn and with a second by Chairman Westbrook the meeting adjourned at 4:45 p.m.
