

RESOLUTION CONT'D.

BEGINNING at a stake N.E.C. of the 7th Civil District west line of 24th District and S.E.C. of 25th District; runs thence west with Gardner road to old Dresden-Latham road; runs thence North and East with Old Dresden-Latham road to point where same intersects with Highway No. 118; thence North with Highway No. 118, to point where said highway crosses Strawbridge branch; thence Northeast with Strawbridge branch to South of the 4th District; thence East with South line of 4th District to Cypress Creek; thence Southeast with Cypress Creek to N. W. Corner of 24th Civil District.

SECTION 2. BE IT FURTHER ENACTED, That this Act shall take effect from and after its passage, the public welfare requiring it.

RESOLUTION TO CHANGE TAX RATE -- SHARON SPECIAL SCHOOL DISTRICT--

An Act to amend Chapter 35 of the Private Acts of the First Extra Session of 193, entitled: "AN ACT entitled AN ACT to create and establish a Special School District out of part of the Eighth Civil District of Weakley County, Tennessee, including the town of Sharon, TO BE KNOWN AS THE "Sharon Special School District;" to define its boundaries; to provide for the government, management, and election of school officers for the same; and to provide revenue for the maintenance of the said School District," as amended by Chapter 51 of the Private Acts of 1919, Chapter 488 of the Private Acts of the Extra Session of 1919, Chapter 400 of the Private Acts of 1923, Chapter 811 of the Private Acts of 1931, Chapter 312 of the Private Acts of 1937, relative to assessments for the support and maintenance of said School District.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1, Chapter 35 of the Private Acts of the First Extra Session of 1913, as amended, is amended by deleting from line eleven (11) of Section 7 of the Chapter as amended after the word "District;" the following words: "Twenty-five cents of said sixty cents herein provided shall be applied to the payment of the bonded indebtedness of said Sharon Special School District", and substituting in lieu thereof, the following:
Ten cents of said sixty cents herein provided shall be applied to the payment of the bonded indebtedness of said Sharon Special School District for a period of one (1) year commencing January 1, 1969.

SECTION 2. This Act shall have no effect unless it is approved by a two-thirds (2/3) vote of the Quarterly County Court of Weakley County on or before July 1, 1969. Its approval or non-approval shall be proclaimed by the presiding officer of the Quarterly County Court and certified by him to the Secretary of State.

SECTION 3. For the purpose of approving this Act as provided in Section 2, it shall take effect on becoming a law, but the other provisions of the Act shall be effective only upon its approval as provided herein.
