

RESOLUTION AUTHORIZING PURCHASE OF INSURANCE AND ESTABLISHING SPECIAL FUND

WHEREAS, certain events have occurred causing enormous increases in insurance rates.

NOW, THEREFORE, BE IT RESOLVED BY the Board of County Commissioners of Weakley County, Tennessee, assembled in regular session on this the 20th day of January, 1986, that:

SECTION 1. The insurance outlined on the attached sheet be purchased including the additional uninsured motorist coverage, but excluding the General Liability coverage and that \$133,000.00 be set aside in a special fund to bear interest and be used for claims or related expenses.

SECTION 2. The following become county policy and be included in the Personnel Handbook.

A. No county owned vehicle shall be operated at anytime by an operator who

- (1) is a high risk operator.
(2) has a poor driving record.
(3) has inadequate experience.
(4) is not properly licensed.

B. No person applying for a job that may occasion him/her to operate a county owned vehicle shall be hired until there is evidence on file, including a current MVR, that he/she is not

- (1) a high risk driver.
(2) a driver with a poor driving record.
(3) a driver having inadequate experience.
(4) a driver without a proper operators license.

C. All department heads shall make every effort to insure that no county owned vehicle is ever operated in adverse weather conditions unnecessarily.

SECTION 3. BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

SECTION 4. BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
