

RESOLUTION NO. 1988-06

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1988.

WHEREAS, in order to comply with TCA 38-10-101 requiring the Sheriff's Department to electronically submit vital statistics and information relating to crime, criminals and criminal activity, and:

WHEREAS, the Tennessee Sheriff's Association has obtained a bid on a new computer system in order to comply with state regulations, and:

WHEREAS, the State of Tennessee has agreed to participate in the cost of the new computer with a grant of fifty (50) percent of the cost, and:

WHEREAS, TCA 8-21-901 (30) allows for additional fee to be collected for each warrent or process that is served by the Sheriff's Department, and:

WHEREAS, the Sheriff's Department budget requires certain adjustments:

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Weakley County, Tennessee, assembled in regular session on this the 19th day of January, 1988; that:
