

RESOLUTION # 1977-36:

A Resolution to Amend the 1977-78 FY  
General Fund Budget.

WHEREAS: The Weakley County Quarterly Court in regular session adopted Resolution # 1977-34, (to place all County offices under T. C.A. Section 8-2204) on the 10th day of August 1977, and:
