RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENN
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1998.

WHEREAS, services have been requested by different agencies for the Sheriff's Department to provide security services; and

WHEREAS, these services provided will require these agencies to pay for the services rendered; and

WHEREAS, the security provided will not be in the normal work duties and in order to provide these services the agencies will pay for overtime plus fringes for time worked; and

WHEREAS, this resolution will provide revenue for the services rendered, to offset the deputy's salary account.

SECTION 1. The Weakley County, General Fund is hereby amended as follows:






