RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENN  
DRUG CONTROL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1998.

WHEREAS, Weakley County Sheriff's Department would like to sell a Drug Fund vehicle to a governmental entity within the County; and

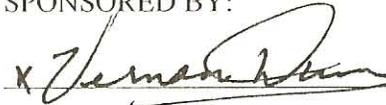

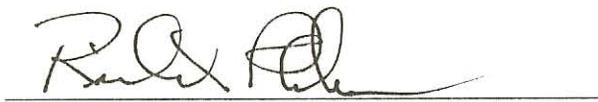

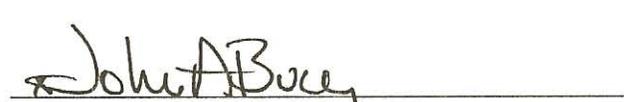
