

**RESOLUTION NO. 1998-87**  
**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE**  
**WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND**  
**FOR THE FISCAL YEAR ENDING JUNE 30, 1998**

WHEREAS, certain events have occurred requiring adjustments in the 1997-98 Highway Fund Budget, Fund # 131 and,

WHEREAS, a transfer is needed in several line items because of unforeseen increases at this time of year and due to the large amount of rock needed in crushed stone for repair of roads.

WHEREAS, these funds are not available elsewhere in the same block of line items,

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 18<sup>th</sup> day of May, 1998 in Dresden, Tennessee that:
