

RESOLUTION NO. 1999-29
RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE
WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND
FOR THE PURPOSE OF P.S.E. ON LIBERTY BRIDGE
FOR THE FISCAL YEAR ENDING JUNE 30, 1999

WHEREAS, certain events have occurred requiring adjustments in the 1998-99 Highway Fund Budget, Fund # 131 and,

WHEREAS, a transfer is needed for the preliminary, survey and engineering for the bridge construction on Liberty Bridge which has been offered to us by the State of Tennessee

WHEREAS, a portion of these funds are not available elsewhere in the same block of line items

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 23rd day of November, 1998 in Dresden, Tennessee that this resolution is hereby approved.
