RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY,  
TENNESSEE CENTRAL CAFETERIA FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2000

WHEREAS, The Weakley County Schools Child Nutrition Program plans to purchase dining room tables for Martin Primary and Central Office Desks and,

WHEREAS, an additional serving unit for Dresden Middle and completion of computerized cashier systems for Dresden High, Westview, Sharon and Central Office plan to be purchased,

AND WHEREAS, these expenses having occurred require an adjustment in the 1999-2000 Fiscal Year of the Weakley County Central Cafeteria budget.
