RESOLUTION AUTHORIZING BUDGET AMENDMENT
TO THE WEAKLEY COUNTY, TENNESSEE GENERAL PURPOSE SCHOOL
FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2000.


