

RESOLUTION NO. 2001-09

RESOLUTION AUTHORIZING THE LEASE OF THE OLD WEAKLEY COUNTY JAIL BUILDING

WHEREAS, the Weakley County Sheriff, Jail, and Emergency Management offices are now located at 7951 Highway 22, Dresden, Tennessee; and

WHEREAS, the property formerly occupied by the Weakley County Sheriff and Emergency Management offices and the County Jail located at 201 Poplar Street, Dresden, Tennessee is no longer needed by Weakley County; and

WHEREAS, the Disabled American Veterans, Weakley County, Tennessee, Chapter #98 has requested a one-year lease of the Old Weakley County Jail Building; and

WHEREAS, the Weakley County Chapter #98, Disabled American Veterans has agreed to furnish all utilities, janitorial services, taxes, insurance, and maintain the premises in a safe and sanitary manner, including maintenance of building and grounds and other costs or expense that might arise; and

WHEREAS, the term of the lease shall be for a one-year period, with the option of renewal on a yearly basis by written agreement of the parties, with a thirty-day written cancellation notice by either party.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 18th day of September, 2000 in Dresden, Tennessee that the County Executive is authorized to enter into an agreement with the Weakley County Chapter #98, Disabled American Veterans to lease the old Weakley County Jail Building for a term of one year which may be terminated by either party giving thirty days written notice.

BE IT FURTHER RESOLVED, that the County Attorney approve the lease as to form and legality.

BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
