

RESOLUTION NO. 2001-12 (AMENDED)

A RESOLUTION TO AMEND THE RULES REGULATING THE PROCEDURES OF THE BOARD OF COUNTY COMMISSIONERS OF WEAKLEY COUNTY, TENNESSEE

WHEREAS, the Weakley County Board of County Commissioners has previously adopted rules of procedure for the Board of County Commissioners, and

WHEREAS, the Weakley County Committee on Committees has met and recommended that the rules be amended,

NOW, THEREFORE, BE IT RESOLVED BY THE WEAKLEY COUNTY COMMISSION MEETING IN REGULAR SESSION ON SEPTEMBER 18, 2000, as follows:

SECTION 1. Rule 1 (Convening of the Board) of the Rules of Procedure of the Weakley County Board of County Commissioners is hereby amended by deleting the first sentence in its entirety and substituting the following language:

The Board shall meet in regular session at the county seat in Weakley County, Tennessee at 7:00 p.m. on the fourth Monday of June and each odd numbered month except for the month of July, when the Board shall meet on the fourth Monday of the month.

SECTION 2. Rule 8 (Committee Structure of Board) subsection A of the Rules of Procedure of the Weakley County Board of County Commissioners is hereby amended by renaming the Committee on Committees to the Rules Committee. Rule 8 subsection B is amended by adding a sentence following the phrase "Weakley County School System." The addition shall read "This committee shall also have responsibility of sanitation and solid waste, including trash, litter control and convenience center operations." Rule 8 is further amended by deleting the phrase "sanitation and solid waste, litter and trash control" from subsection B.(3)

SECTION 3. This resolution shall become effective upon passage, the public welfare requiring it.
