

**RESOLUTION NO. 2001-16**

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE  
WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2001**

**WHEREAS**, additional funds are being received from the State of Tennessee State Aid Grant money to be used in hot mixing Weakley County roads; and

**WHEREAS**, \$11,546 of State Aid money remains from the 99-00 FY budget, Weakley County will receive \$218,339 of State Aid money for the 2000-2001 FY, Weakley County must provide the 25% county match; and

**WHEREAS**, a budget amendment is necessary to increase the State Aid revenue account \$7,160, to decrease the Highway Fund Balance account \$14,073 for the 25% county match for the additional state aid money, and to increase the State Aid expenditure account \$21,233; and

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 20<sup>th</sup> day of November, 2000 in Dresden, Tennessee that:

**SECTION 1.** The Weakley County Highway Fund is hereby amended as follows:






