

RESOLUTION NO. 2001-33

RESOLUTION AUTHORIZING THE EXECUTION OF AN EASEMENT TO CITY OF GREENFIELD, TENNESSEE

WHEREAS, the City of Greenfield is proposing to establish a new water well inside its corporate city limits to be located on the northeast corner of its property identified as Weakley County Tax Map 155-E, Group C, Parcel 1.01; and

WHEREAS, the water pumped from said location must be transported to the City of Greenfield water treatment plant which is located at Weakley County Tax Map 155-E/B, Group A, Parcel 1; and

WHEREAS, the water lines necessary to transport said water from the new water well location to the water treatment plant must necessarily cross the eastern portion of land owned by Weakley County, Tennessee, for the use and benefit of the Weakley County Municipal Electric System as can be found in the Register's Office of Weakley County, Tennessee, in Deed Book 112, Page 344, and further identified as Weakley County Tax Map 155-E, Group C, Parcel 19; and

WHEREAS, the City of Greenfield has prepared a proposed Easement for a ten (10) foot permanent easement and two adjacent five (5) foot temporary construction easements as well as a permanent easement for ingress and egress.

NOW THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee, assembled in regular session on this the 16th day of January, 2001, in Dresden, Tennessee, that the County Executive is authorized to enter an Easement for the benefit of the City of Greenfield for the purpose of constructing and maintaining water lines and ingress and egress across Weakley County Tax Map 155-E, Group C, Parcel 19.


BE IT FURTHER RESOLVED, that the County Attorney approve the Easement as to form and legality.




