RESOLUTION NO. 2004-04

**2003-2004 FY TENTATIVE BUDGET FOR THE WEAKLEY COUNTY
GENERAL FUND, WEAKLEY COUNTY HIGHWAY FUND,
WEAKLEY COUNTY DEBT SERVICE FUND, WEAKLEY COUNTY
DEPARTMENT OF EDUCATION FUND, AND SOLID WASTE FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 2003.**

WHEREAS, the Weakley County has not adopted the 2003-2004 FY budget; and

WHEREAS, Resolution #2003-37 stated that no more than 1/12th of any item be expended per calendar month by each Department without the approval of the Weakley County Board of Commissioners Finance, Ways, and Means Committee until the final 2003-2004 FY Budget is adopted.

WHEREAS, Weakley County officials have requested the spending limitation of 1/12th of any line item be increased; and

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 28th day of July 2003 in Dresden, Tennessee that the adopted Weakley County 2002-2003 General Fund, Highway Fund, Debt Service Fund, Department of Education, and Solid Waste Fund budgets be adopted as the 2003-2004 FY Tentative Budget; and


SECTION 1. BE IT FURTHER RESOLVED, that no more than 1/6th of any item be expended per calendar month by each Department without the approval of the Weakley County Board of Commissioners Finance, Ways, and Means Committee until the final 2003-2004 FY Budget is adopted.

SECTION 2. BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

SECTION 3. BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.






