

RESOLUTION NO. 2004-11

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2004

WHEREAS, the Weakley County Juvenile Court has received a grant in the amount of \$11,800 from the State of Tennessee; and

WHEREAS, the purpose of the grant is to assist non-custodial parents who are referred to the Weakley County Juvenile Court for the purpose of child support enforcement to have set visitation with their child or children; and

WHEREAS, the grant allows for the hiring of one part-time employee for the grant period of ten months, the part-time position will be fully funded utilizing the non-custodial grant funds; and

WHEREAS, the part-time position will cease upon depletion of non-custodial grant funds.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 17th of November 2003 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund is hereby amended as follows:

SECTION 2. BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

SECTION 3. BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
