

**RESOLUTION NO. 2005-12**

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN GENERAL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2005**

**WHEREAS**, the Weakley County Juvenile Court has received a grant in the amount of \$13,800 from the State of Tennessee; and

**WHEREAS**, the purpose of the grant is to assist non-custodial parents who are referred to the Weakley County Juvenile Court for the purpose of child support enforcement to have set visitation with their child or children; and

**WHEREAS**, the grant allows for the hiring of one part-time employee for the grant period of ten months, the part-time position will be fully funded utilizing the non-custodial grant funds; and

**WHEREAS**, the part-time position will cease upon depletion of non-custodial grant funds.

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 15<sup>th</sup> of November 2004 in Dresden, Tennessee that:


**SECTION 1.** The Weakley County General Fund is hereby amended as follows:


