

RESOLUTION NO. 2005-26

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2005

WHEREAS, the Ned R. McWherter/Weakley County Library has received grant funds in the amount of \$1,200 from the TN Department of State TN State Library and Archives; and

WHEREAS, these grant funds must be matched with an equal local amount. These funds are to be used to upgrade/replace computers with current model personal computers that are for pubic access or as servers for a public access network;

WHEREAS, additional funds in the amount of \$8,356 will be received from the TN Department of Health and the Weakley County Health Department DGA grant budget should be amended; and

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 21<sup>st</sup> of March 2005 in Dresden, Tennessee that:
