

RESOLUTION NO. 2005-32  
RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE  
WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2005
