

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN GENERAL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2005**

**WHEREAS**, the Weakley County Emergency Management has received two grants from TEMA; and

**WHEREAS**, one grant is in the amount of \$50,000 to provide a vehicle for the Emergency Management personnel's use to respond to all incidents; and

**WHEREAS**, the second grant is in the amount of \$103,272 to provide an initial strategy implementation plan based upon the State's Homeland Security Strategy to prevent and protect citizens for the threat of terrorism and to respond to terrorist acts.

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 20<sup>th</sup> of June 2005 in Dresden, Tennessee that:


**SECTION 1.** The Weakley County General Fund is hereby amended as follows:






