

AUTHORIZING THE SUBMITTAL OF AN APPLICATION TO THE TENNESSEE DEPARTMENT OF ECONOMIC & COMMUNITY DEVELOPMENT FOR A FY2006 COMMUNITY DEVELOPMENT BLOCK GRANT

WHEREAS, the Weakley County Commission of Weakley County, Tennessee have committed themselves to improve and enhance community livability for the citizens they represent; and

WHEREAS, said public officials have determined that the addressing of connecting the Dresden High School's Sewer System to the City of Dresden's Sewer System is the most pressing need that can be addressed with grant assistance from the Community Development Block Grant Program; and

WHEREAS, Weakley County wishes to make an application to make said Sewer Line Extension in the total amount of \$325,978. This is a request of \$280,341 (86%) from the CDBG Program plus \$9,779 (3%) from the Three-Star Program. The remaining funds in the amount of \$35,858 (11%) will be furnished by Weakley County and taken from Weakley County Educational Capital Project funds.





Motion made by Commissioner Rook that the foregoing resolution be adopted: Motion seconded by Commissioner Jones.
