

RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN. GENERAL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2006

WHEREAS, funds in the amount of \$260.00 have been requested from the Weakley County Office on Aging/Senior Citizens Center to contract with an aerobic instructor to teach aerobic classes at the Weakley County Office on Aging/Senior Citizens Center for four months; and
