

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2007

WHEREAS, a budget amendment is necessary to disburse incoming revenue into certain line items in the Highway Budget; and

WHEREAS, these funds are received from State of Tennessee Disaster Relief 2003 grant.

SECTION 1. The Weakley County Highway Fund is hereby amended as follows:


