

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2007**

WHEREAS, the Weakley County Sheriff has been successful in obtaining a State of Tennessee Department of Transportation grant in the amount of \$5,000 to undertake the police traffic services highway safety project to reduce speeding, aggressive driving, driving under the influence, and non-seat belt usage for children and passengers; and

WHEREAS, the grant funds will be used to purchase radars and in-car video equipment; and

WHEREAS, the Emergency Management possess a balance of 2004 homeland security grant funds from the State of Tennessee in the amount of \$2,951; and

WHEREAS, the grant funds will be used to purchase disaster ready supplies and communication equipment.

NOW, THEREFORE BE IT RESOLVED, by county legislative body of Weakley County, Tennessee assembled in regular session on this the 20th day of November 2006 in Dresden, Tennessee that:


SECTION 1. The Weakley County General Fund is hereby amended as follows:






