

RESOLUTION NO. 2007-22

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2007.**

WHEREAS, the Health, Education, & Economic Development Committee along with the Finance, Ways, & Means Committee have concluded that the old Weakley County Jail building and ~~the Election Commission building~~ are in need of demolition; and

WHEREAS, these structures will be torn down and debris removed by licensed and bonded contractors, leaving the concrete slabs, the Weakley County Highway Department has committed to the removal of the concrete slabs; and

WHEREAS, sealed bids have been received for the demolition work with the price being \$64,950 for both structures.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 20th day of November, 2006 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund is hereby amended as follows:


