

RESOLUTION NO. 2007-31  
AUTHORIZING SECTION OF ROAD CLOSURE  
FOR THE WEAKLEY COUNTY HIGHWAY DEPARTMENT

WHEREAS, two sections of road with no name near Sidonia, Tennessee and in County Commission District 4 has been petitioned to the road board for (2) sections of closure for the purpose of safety and security; and

WHEREAS, both sections of road for closure are approximately .2 mile in length and both begin at Bob Miles Road and travel north to dead end; and

WHEREAS, the Weakley County Board of Highway Commissioners recommends closure of said sections off Bob Miles Road; and

NOW, THEREFORE BE IT RESOLVED, that the Weakley County Board of Commissioner assembled in regular session of this the 19<sup>th</sup> day of March, 2007 does hereby approve the closure of (2) sections of road off Bob Miles Rd; and

BE IT FURTHER RESOLVED, that the road application is attached as \*Ex.A and the map depicting the Location of said sections is \*Ex. B; and

BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
