

**RESOLUTION NO. 2007-34**

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN  
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2007.**

**WHEREAS**, the Health, Education, & Economic Development Committee along with the Finance, Ways, & Means Committee have concluded that the Weakley County Election Commission building is in need of demolition; and

**WHEREAS**, the structure along with the basement will be torn down and debris removed by licensed and bonded contractor; and

**WHEREAS**, sealed bids have been received for the demolition work with the price being \$46,500 for the structure.

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 19<sup>th</sup> day of March, 2007 in Dresden, Tennessee that:


