

RESOLUTION TO APPOINT THE WEAKLEY COUNTY MEDICAL EXAMINER AND THE COUNTY CORNER/MEDICAL INVESTIGATOR

WHEREAS, Section 38-7-104, TCA provides that a county medical examiner shall be elected by the county legislative body of each county in the state; and

WHEREAS, the county medical examiner shall be a physician who is a graduate of an accredited medical school authorized to confer upon graduates the degree of doctor of medicine (M.D.); and

WHEREAS, the County is authorized to set the compensation of the county medical examiner in an amount not to exceed seventy-five dollars (\$75.00) for each death the county medical examiner investigates.

NOW, THEREFORE, BE IT RESOLVED the Weakley County Legislative Body meeting in Regular Session at Dresden, Tennessee, on this 28th day of June, 2007 that Dr. O. K. Smith, Jr. be appointed Weakley County medical examiner for the year ending August 31, 2007 and that his compensation shall be \$75.00 for each death he investigates.

BE IT FURTHER RESOLVED, that the Weakley County medical examiner be authorized to appoint a County medical investigator to assist him in his duties.

BE IT FURTHER RESOLVED, that Rick Workman be appointed Weakley County Corner for the year ending August 31, 2007 and that his compensation shall be seventy-five dollars (\$75.00) for each death he investigates when the death is believed to be due to unlawful violence, TCA §38-5-101.

BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

BE IT FURTHER RESOLVED, that this resolution shall take effect upon passage by a majority of the members of the Board of County Commissioners of Weakley County, Tennessee.
