

RESOLUTION NO. 2008-32

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2008.

WHEREAS, the State of Tennessee has awarded the Weakley County Sheriff's Department a \$5,000 Highway Safety grant, with no local match, to purchase vehicle in-car video equipment, DUI checkpoint supplies, and other law enforcement equipment; and

WHEREAS, Weakley County is the recipient of a courtroom audio enhancement grant from the State of Tennessee that requires a 10% local match; and

WHEREAS, funds need to be budgeted for temporary personnel employment in the Circuit Court office due to the medical leave of one employee.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 24th day of March, 2008 in Dresden, Tennessee that:


