

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN
HIGHWAY FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2008**

WHEREAS, transfer of funds in the Highway Department is necessary among various line items due to price increases of products and more expenditures than anticipated; and

WHEREAS, the Finance, Ways, & Means Committee placed the excess \$65,000 in the Highway Fund undesignated fund balance line item.

SECTION 1. The Weakley County Highway Fund is hereby amended as follows:


