

RESOLUTION NO. 2009-08

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2009.

WHEREAS, Weakley County is the recipient of additional funds from the courtroom audio enhancement grant provided by the State of Tennessee; and

WHEREAS, the State of Tennessee has awarded the Emergency Management Office a community enhancement grant; and

WHEREAS, additional funds need to be appropriated for temporary personnel in the Clerk and Master's office due to the medical leave of one employee.

SECTION 1. The Weakley County General Fund is hereby amended as follows:


