

RESOLUTION AUTHORIZING BUDGET AMENDMENTS AND  
WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2009

WHEREAS, a budget amendment is necessary to transfer funds from within the budget to Highway Equipment line item which is in need of extra funds for the purchase of a dump truck; AND

WHEREAS, extra funds are available in the gasoline line due to lower prices for a few months and in the unemployment line due to those laid off obtaining other jobs instead of drawing unemployment.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 23rd day of March, 2009 in Dresden, Tennessee that this resolution is hereby approved.
