

RESOLUTION NO. 2009-30

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2009.

WHEREAS, the commissary program conducted at the Weakley County Jail has purchased and sold additional inmate telephone cards this fiscal year, additional funds have been received and should be property budgeted; and

WHEREAS, the Sheriff's Department has received additional funds for the training of certified officers; additional funds have been received and should be property budgeted; and

WHEREAS, the Emergency Management office has received additional grant funds for the purchase of equipment and supplies to conduct a Hazmat training and a full scale hazardous materials response exercise. The grant total is \$10,500 with a \$2,100 local match that will be provided with in-kind resources, resulting in the receipt of \$8,400 from the State of Tennessee.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 23rd day of March, 2009 in Dresden, Tennessee that:




