

AUTHORIZING THE SUBMITTAL OF AN APPLICATION TO THE TENNESSEE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT FOR THE SMALL CITIES BLOCK GRANT PROGRAM/CDBG FOR FISCAL YEAR 2009

WHEREAS, the governing body of Weakley County, Tennessee, having committed itself to the improvement of the community that it represents, wishes to make application for the funding of a Fire Truck and Air Pack purchase, and,

WHEREAS, having determined proper eligibility by CDBG program guidelines, said governing body wishes to make application for \$190,259 in grant funds to implement the aforementioned improvements and Palmersville Volunteer Fire Department will commit funds in the amount of \$14,321 to constitute a total project cost of \$204,580.

NOW, THEREFORE BE IT RESOLVED by the governing body of Weakley County, Tennessee, meeting in session on this the 23rd day of March, 2009 that the County Mayor of Weakley County is authorized to sign an application for CDBG funds, to commit local matching funds to the proposed project, and to sign and all necessary assurances, agreements or contracts required for recipients of CDBG funds.

BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the, Board of County Commissioners.
