RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2010.

WHEREAS, the State of Tennessee has awarded the Weakley County Sheriff's Department a \$5,000 Highway Safety grant, with no local match, to purchase vehicle in-car video equipment, mobile radar unit, laptop computer, and other law enforcement equipment.
