

RESOLUTION AUTHORIZING BUDGET AMENDMENTS
 TO THE GENERAL FUND
 FOR THE YEAR ENDING JUNE 30, 1993

WHEREAS, The Weakley County Juvenile Court has had to place several juveniles into a Juvenile Detention Center either in Madison County or Shelby County, with the cost being \$75.00 per day, and,

WHEREAS, because of the seriousness of the charges or the possibility of absconding from the courts' jurisdiction, the juveniles were ordered to be kept in a secure detention facility.

WHEREAS, also I have been allowed to drive a county vehicle (an old Sheriff's Department vehicle), and need to establish an line item for the maintance of the vehicle.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Weakley County, Tennessee assembled in regular session on this 24th day of January, 1994; that:

SECTION 1. The General Fund is hereby amended as follows:
