

**RESOLUTION TO APPROVE WEAKLEY COUNTY OFFICIALS
STATUTORY BONDS FOR COUNTY PUBLIC OFFICIALS**

WHEREAS, Tennessee Code Annotated §8-19-101 *et. seq.*, establishes that county constitutional officials must execute a surety bond; and

WHEREAS, the proper surety bonds have been executed and are prescribed as below; and

WHEREAS, Weakley County constitutional officials and any other official vested by law the authority to administer state shared funds must be approved by the county legislative body, recorded in the office of register of deeds and transmitted to the comptroller of the treasury for safekeeping.




