RESOLUTION TO CORRECT SCRIVENER'S ERROR IN RESOLUTION 2011-40  
RESOLUTION TO AMEND RESOLUTION 1979-32, SECTION 9 IN REGARDS TO  
MOTOR VEHICLE PRIVILEGE TAX IN WEAKLEY COUNTY.

WHEREAS, on May 23, 2011, the Weakley County Board of Commissioners passed Resolution No. 2011-40 "Resolution to Amend Resolution 1979-32, Section 9 in Regards to Motor Vehicle Privilege Tax in Weakley County; and

WHEREAS, certain scrivener's errors were contained in said Resolution 2011-40 confusing the intent and will of the Board; and

WHEREAS, it is the intent of the Board by the passage of the Instant Resolution to correct and remedy said scrivener's error and to conform Resolution 2011-40 to its intended purpose and effect; and


WHEREAS, it is the intent to include exemption of the Weakley County motor vehicle privilege tax for residents, one (1) license plate per household, who qualify to receive the Gold Star Family, Purple Heart, Congressional Medal of Honor, Disabled Veteran, Legion of Valor, or Prisoner of War.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 30<sup>th</sup> day of June, 2011 in Dresden, Tennessee that the Weakley County Commission amends Resolution No. 2011-40 to include exemption for those who qualify to receive the Gold Star Family, Purple Heart, Congressional Medal of Honor, Disabled Veteran, Legion of Valor, or Prisoner of War license plates.

BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
