The Successful Bidder, submitting a Labor and Material Bid in excess of \$25,000 will be required to furnish and pay for satisfactory Performance and Payment Bond or Bonds equal to 100% of the Bid Amount.

All Bidders must comply with the applicable provisions of Public Chapter 822, House Bill 2180, Senate Bill 1824, commonly known as the Contractor's Licensing Act of 1976, as amended.

All successful Bidders shall provide a Tennessee Drug Free Work Place Membership Affidavit prior to being awarded a Contract.
